CORRECTED RESOLUTION NO. 2015-12-09

WHEREAS, the Mayor and City Council of the City of Victor passed and adopted Resolution No. 2015-12-09 on December 9, 2015; and, among other things, this Resolution references the following 2 Exhibits: (i) Exhibit A being a survey of the Victor Urban Renewal Area and (ii) Exhibit B being a survey of the Downtown Victor Urban Renewal District, which depicts the Victor Revenue Allocation Area pursuant to Idaho Code 50-2903(15) (as the same was defined in Ordinance No. 2015-12-09(3); and

WHEREAS, the legal description contained in Exhibit B, as originally passed, contains certain scrivener errors relative to certain land that was to be excluded; and

WHEREAS, the conceptual map of the Downtown Victor Urban Renewal District presented to the Victor City Council the Mayor and published in the paper for purposes of notice of the public hearing on Ordinance No. 2015-12-09(3) were in all respects correct, and continued to be correct at the time of review by the City Council and the City Council's passage of the Resolution; and

WHEREAS, the Mayor and City Council wish to rename the Downtown Victor Urban Renewal District as the "Victor Revenue Allocation Area" (the "RAA") to maintain consistency with the name given to this area in Ordinance 2015-12-09(3), and to maintain consistency with Idaho Code 50-2903(15); and

WHEREAS, correction to Exhibit B serves only as a scriveners correction as the surveyor made an error in the survey provided to the City when it was prepared for use as an exhibit to Resolution No. 2015-12-09(3); and

WHEREAS, the Mayor and City Council now desire to formally correct Exhibit B to Resolution No. 2015-12-09(3).

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF VICTOR AS FOLLOWS:

- I. Exhibit B to Resolution No. 2015-12-09 is hereby renamed the Victor Revenue Allocation Area.
- II. Exhibit B is hereby corrected to depict the RAA as set forth on the exhibit attached to this Corrected Resolution NO. 2015-12-09.
