

City Council Meeting

February 1, 2019

Victor, ID

The Victor City Council met in special session in the Council Chambers of City Hall at 32 Elm Street at 9:00am. Upon roll call the following were found to be present:

Mayor & Council: Jeff Potter, Tim Wells, Molly Absolon, Will Frohlich called in. Dustin was absent.
Staff: Olivia Goodale, Michelle Smith, Ryan Krueger, Herb Heimerl, and Tyler Steinway.

Public Hearing/Action Items:

Snow X Event request for fee waiver. Olivia made staff comment regarding the request for fees to be waived for the event on February 8 and 9. Discussion followed on how many hours that it might take with city equipment and staff time. Wade Kaufman made public comment regarding the history of the event and stated the participants are younger kids starting out with snow racing and this isn't a big money maker but brings families into the city. Further deliberation was made between council about the flexibility and where will the fees come from in the budget. Olivia stated that there is no policy in place, and it is up to council discretion at this point.

A motion was made by Councilman Wells and seconded by Councilwoman Absolon to approve the request from the Skyliners and Intermountain Snow X to waive associated fees for City services for the Snow X race. Mayor Potter called for the vote the vote showed all in favor. The motion carried.

Public Hearing- Design Review and Design Standards and Guidelines and Interim Ordinance O536, An Interim Ordinance Amending and Restating Section 6.10 of Article 14 of Title 10 of the Victor City Code Regarding Design Review. Ryan Krueger confirmed that proper notice has been given and that supporting materials are complete. No Council members declared a conflict of interest. Ryan Krueger made staff comment regarding the purpose and updates needed for the interim ordinance that would apply to new construction and that the specific standards and guidelines established with the design review committee were not able to be finalized following the adoption of the previous interim ordinance due to staff changes. This will help allow for the time necessary to modify the design review and standard for the City of Victor.

A motion was made by Councilman Wells and seconded by Councilwoman Absolon to waive the first reading in full of Ordinance O536 amending and reenacting Section 6.10 of Article 14 of Title 10, read it by title only, and waive the second and third ordinance readings. Mayor Potter called for the vote. The vote showed all in favor. The motion carried.

A motion was made by Councilman Wells and seconded by Councilwoman Absolon to approve Ordinance O536 amending and reenacting Section 6.10 of Article 14 of Title 10 and its summary, and to direct the City Clerk to publish the summary. Mayor Potter called for a roll call vote. Councilman Frohlich- In Favor, Councilman Wells- In Favor, Councilwoman Absolon- In Favor. The motion carried.

Adjourn. A motion was made by Councilman Wells and seconded by Councilwoman Absolon to adjourn the meeting. Mayor Potter called for the vote. The vote showed all in favor. The motion carried. The meeting adjourned at 9:12 A.M.
