PURPOSE & PROCESS

The purpose of this item is to review the first community survey for the City Hall and Public Works Facilities Project.

Next Steps: The survey results will be folded into the facilities assessment.

BACKGROUND/ALTERNATIVES

The City of Victor is entering the early stages of conducting a City Hall and Public Works facilities assessment. The assessment will explore current and future service and space needs of the facilities and analyze related renovation options and potential construction sites. The purpose of the first community survey was to gain initial community feedback to inform the project assessment. The survey asked for input regarding what community values and roles should be reflected in the facilities, project phasing, in addition to accepting any initial comments.

During its September 9th City Council meeting, Council reviewed the initial survey results. Because only 68 people responded to the survey, Council asked that the survey be reopened for another two weeks. 140 people have now responded to the survey, of which 69% indicated they were residents of Victor. Attached please find the full survey results and comments submitted.

Staff is looking for <u>initial input</u> on how to proceed to the next step of the assessment, a service and space needs analysis, specifically with regard to City Hall. (Please note, this topic will be revisited and discussed further as part of the service and space analysis component of the facilities assessment.)

 In addition to traditional city hall services, should staff explore adding square footage to the facility for additional services such as a community gathering space, indoor or outdoor? If so, to what scale (additional uses for council chambers or small outdoor areas vs. full community center, for example)? Any other additional services? <u>Project Background:</u> Any member of the community is invited to schedule a tour of the old building at 32 Elm Street with City Staff.

In 2019, safety issues related to the old Victor City Hall located at 32 Elm Street appeared. Inspection reports showed multiple safety concerns including larger issues relating to fire walls separating shop areas from office and public use areas, permanent wiring, the ceiling, ventilation, lack of means of egress in some areas or means of egress being too far from office space (floor plan), and failure to comply with ADA accessibility requirements in the public bathroom and main entrance. The safety issues were so extensive that administrative offices moved to a temporary, rented location at 10 South Main Street. The public works department continues to operate out of 32 Elm Street because the space functions more as a shop environment, as the building was originally intended for.

On July 8, 2020, Victor City Council explored the feasibility for administration and public works services to function out of the same space at 32 Elm Street into the future. After considering the space needs of both administrative and public works services in the immediate and mid-term, the short comings of development code requirements and design guidelines, and the inspection reports, City Council determined that it is not feasible for administrative and public works to function out of 32 Elm Street and further directed that the City needs to explore other long term solutions for both a safe and functional City Hall and Public Works facility.



Q1 What community values should be reflected in the future City Hall and Public Works facilities? Click all that apply:




Q2 What role would you like the Victor City Hall facility to have in the community? Click all that apply:



- Keep costs minimal.
- Don't waste our precious tax payer money on something that isn't even needed. I know you guys like to spend all of our money, it's as if it's you're number one goal to suck us dry, please don't... for the sake of everybody. Pull your head out of your ass.
- The survey questions reads as if you are stating opinions rather than fact. Trying to get people to think a certain way. I live here for the small town life and not for making the town bigger and more developed. If you live here for what it is then leave it as it is, a smll town. If you want to live in a devloped city or big town move to one. Leave my home alone. Also taxes are bad enough, how are you going to pay for it?
- I have toured the Elm St facility. Most do not realize that building is in terrible condition. A growing City absolutely needs a commodious, modern, efficient, attractive, and above all safe facility. Victor MUST secure a NEW building. It 's presence in the downtown at 33/31 will spur growth that will offset some of the costs, best borne via bonding. Every day the cost will rise further so now is the time to put a bond before the voters, once a suitable site can be designated and secured. The elementary school site remains perhaps a option, so does the coffee corner at 31/33 and of course Victor Commons itself (as is or substantially redesigned). The comp plan update should anticipate this action. A central location would be highly preferred by most I believe. Combining city hall with the library, community center and more would be great if it pencils out favorably. Some segmenting of functions might be accommodated by procuring secondary sites for the fire department and allied service activities located perhaps in a partially rebuilt version of the old city hall. Victor Commons has potential of course though a 2-3 story building on that site might better serve the interests of downtown development. The new city hall in any case should be built so as to anticipate two or three decades of usage and the growth in demand for administrative space. The city might purchase certain adjoining properties then capture the appreciation in their value as the new city hall comes on line. Acquisition of a central location is paramount but central space costs more. Subsequent expansion could be vertical not horizontal. Our city staff absolutely requires a safe, clean, attractive facility. Urban Renewal might assist in street- Scaping. A fall back site with room for parking might be the old "foundation" site" at 31 and Crystal.
- The triangle of land to the SE of ice rink is essentially wasted public space. It is cut off
 from the rest of sherman park and essentially wasted untaxed space right now. Puttin a
 city hall/small community center, utilized existing space and parking, is close to
 downtown and provides room for growth. Municipal government should vacate
 downtown office space to leave room for commercial.
- Would the city revisit the Old Depot plans developed in 2009/10?
- Please spend tax payer money responsibly.

- This sounds ridiculous! The depot was purchased for the purpose of serving as city hall. Sell the depot or utilize it for what the initial purchase was for.
